### Full Membership

Open to individuals who function as economic development personnel within an Indigenous community or organization. Full members enjoy all the benefits of Cando membership & have full voting privileges at national and regional meetings. Subject to verification of eligibility.

### Associate Membership

Open to any individual who supports Cando's goals & objectives and is interested in keeping abreast of our activities. Associate members do not have voting privileges but enjoy all other benefits of Cando membership.

### Organization Membership

Open to companies, organizations, agencies, associations, post-secondary institutions and other groups that support Cando's goals and objectives and are interested in keeping abreast of our activities. Corporate members do not have voting privileges but enjoy all other benefits of Cando membership.

### Student Membership
